1. Practice Vision: Dr L asked whether there was any further suggestions to our Practice Vision Statement.

PPG members were more than happy with this statement therefore it has been accepted as our statement and will be published on our Practice Website

- 2. Late Evenings: DrL explained the surgery are introducing late GP clinics on Mondays evenings from April 2015. The times have been agreed by GPs in principal but will be finalised at the next GP meeting. JJ asked if we could advertise this development. PS agreed to display this on the Jayex Board in the patient waiting area. PS confirmed these late sessions would be trialed for a couple of months and then the service would be reviewed.
  - Advertising on the in-house TV was suggested. After much discussion it
    was agreed to bring this back to the next meeting which would give the PPG
    time to assess whether the TV continues to be of patient benefit.

4. Finger Stools/Stubbs: this item was brought from the previous meeting. JP confirmed these items are now in situ and in current use.

ED praised the appointment availability which offers patients appointments within 48hr.

JJ asked whether staff is fully trained in First Aid. PS confirmed CPR and Automatic Electronic Device are part on the ongoing training for all staff – most recently, this training was delivered on 19<sup>th</sup> February 2015.

PPG commended the practice for their efficiencies in staff training and felt this would give the patients confidence in our staff knowing they are fully trained.
